Statement of Nature, Reasons and Basis for Filing

Section 6.45 of Bison's Tariff provides that Bison will file an annual report on or before May 1 of each year reflecting the operational purchases and sales for the preceding calendar year. The report shall state the source, date, volumes, costs and revenues, and all entities from which Bison purchased or sold operational gas, for all operational purchases and sales transactions.

To comply with this filing requirement, Bison is submitting an annual report of operational purchases and sales, attached hereto as Appendix A. The report reflects that Bison made operational sales as more fully identified in the attached report. The attached report additionally includes information relating to the disposition of costs associated with the purchases of gas.
