Pursuant to the Federal Energy Regulatory Commission's ("FERC" or "Commission") Order to Show Cause issued on March 20, 2014, in Docket No. RP14-442-000,¹ Bison Pipeline LLC ("Bison") hereby submits for filing information which demonstrates its compliance with Commission regulations regarding the posting of offers to purchase released capacity, as further described herein.

Statement of Nature, Reasons and Basis for Filing

In its Show Cause Order, the Commission required that all interstate pipelines submit filings to either revise their tariffs to provide for the posting of offers to purchase released capacity or otherwise demonstrate full compliance with the Commission's regulations. Specifically, Section 284.8(d) of the Commission's regulations² requires pipelines to provide notice of offers to purchase released capacity and to post the terms and conditions of such offers on their Internet websites for a reasonable period.

To comply with Ordering Paragraph A of the Show Cause Order as well as Section 284.8(d) of the Commission's regulations, Bison hereby states that its current tariff specifically addresses potential replacement shippers' ability to post, for a period of twenty days, offers to acquire released firm capacity, in addition to the terms and conditions pursuant to which released capacity will be accepted.³

Furthermore, upon receipt of offers to purchase released capacity, Bison will post such offers on its website under Informational Postings. Specifically, such postings would be found on Bison's Informational Postings under "Notices," subcategory "Non-Critical Postings," notice-type "Capacity Release." However, it should be noted that Bison has not received any such offers to purchase released capacity to date.

Other Filings Which May Affect this Proceeding

There are no other filings before the Commission that may significantly affect the changes proposed herein.
